

Terms of Service

Thank you for using our services hereinafter referred to as “Filmteractive Network”. The legal entity responsible for providing Filmteractive Network is the Lodz Media Klaster Foundation represented by Mrs Beata Cygan, with its head office in Lodz, Łąkowa 25, 90-554 Łódź, and registered under 0000287861, and having the following EU VAT number: PL 7272710297.

Those Terms of Service refer to the terms and conditions of use of Filmteractive Network (available at <http://network.filmteractive.eu>) by its users (hereinafter referred to as “Users”). By using Filmteractive Network, you are agreeing to the terms specified below. Please, read them carefully.

Using our Services

You must follow all the policies made available to you within Filmteractive Network.

Do not misuse Filmteractive Network, by for instance interfering with or trying to access it, using a method other than the interface and the instructions that we provide. You may use Filmteractive Network only as permitted by law. We have the right to suspend or stop providing our services to you, should you not comply with our terms, or if a suspected misconduct is being investigated.

Using Filmteractive Network does not give you the ownership of any intellectual property rights in our services or the content you access. You may not use Filmteractive Network content unless you obtain permission from its owner or are otherwise permitted by law. These terms do not grant you to use any branding or logotypes used by Filmteractive Network.

In connection with your use of Filmteractive Network, we may send you service announcements, administrative messages, and other information.

Network Access and Technical Specifications

Filmteractive Network is an Internet service, operating within the boundaries of the official Filmteractive website. The aim of Filmteractive Network is to enable its Users to:

- 1) register a user account by submitting the following obligatory information: name, e-mail address, password, country, workplace, Network category: buyer, seller, networker;

- 2) connect with one another, share basic information (such as name, e-mail address, company name, connection purpose, any specified links to other services and websites), and network;
- 3) register the audiovisual projects and place the information them for the Filmteractive Network Users to browse through;
- 4) view the descriptions of the audiovisual projects submitted via Filmteractive Network.

Privacy Policy

Personal information collected

We collect information:

- 1) When you register an account to become a Filmteractive Network user (“User”), such as your name, e-mail, employer, country, and a password.
- 2) When you view and interact with Filmteractive Network pages, features, and functionality. We also collect your IP address, browser type, operating system, mobile carrier, and your ISP (Internet Service Provider).
- 3) Through cookies and other technologies that allow us to recognize you.

Use of personal information

We use the information you provide to:

- 1) Enable you to share your information and communicate with other Users;
- 2) Enable you to register your projects for Filmteractive Market and make them available for viewing for other Filmteractive Network Users;
- 3) Enable you to browse through the projects registered for Filmteractive Market;
- 4) Administer your account with us and customize the service we provide to you and other Users;
- 5) Send you service or promotional communications through the email you provided;
- 6) Connect you to opportunities by enabling other professionals to find you on Filmteractive Network.

We do not sell, rent, or otherwise provide personally identifiable information to third parties without your consent. We also provide you with the means to control whether or not your contact information is viewable to other Users through your profile.

Your Information Choices

You can:

- 1) Review, enhance or edit your personal information through your personal profile page;
- 2) Change your settings to control visibility of your personal information;
- 3) Tell us to close your Filmteractive Network account.

Your obligations to other Users

- 1) Do not abuse the Filmteractive Network service by using it to spam, abuse, harass, or otherwise violate the Privacy Policy.

Security

- 1) Personal information you provide will be secured in accordance with industry standards and technology.
